## REPORT TO THE BOARD

### 2025 Joint Levy for Taxes to be Collected in 2026

On October 27, 2025, the Board of Trustees approved to increase the **levy amount** by 1.0% over the prior year's levy amount with Resolution 25-05. The certified levy amount was provided to the Snohomish County Assessor's and the Island County Assessor's office on November 7, 2025. Between November 7<sup>th</sup> and December 31<sup>st</sup>, changes to assessed property tax values in both Snohomish and Island Counties can occur through appeals, exemptions, and destroyed properties. Once the assessed property tax values are locked on December 31<sup>st</sup>, both Snohomish and Island Counties calculate the final levy amounts, which are then combined to calculate the **joint levy rate**. This is the rate that the Board of Trustees is certifying on January 8, 2026.

The joint levy rate to certify is thirty cents or \$0.3039084203 per \$1,000 of assessed value, resulting in \$68,525,299.52 of property tax revenue. This certified levy rate results in \$230,700.48 less property tax revenue than what was approved in the 2026 budget on November 24, 2025 of \$68,756,000.

Staff recommends the Board of Trustees certify the levy rate of \$.3039084203 to be forwarded to the Island and Snohomish County Assessor's office after adoption of the resolution.
